PARCEL A is irrevocably offered for dedication to the County of Humboldt, public road purposes and all purposes incidental thereto.

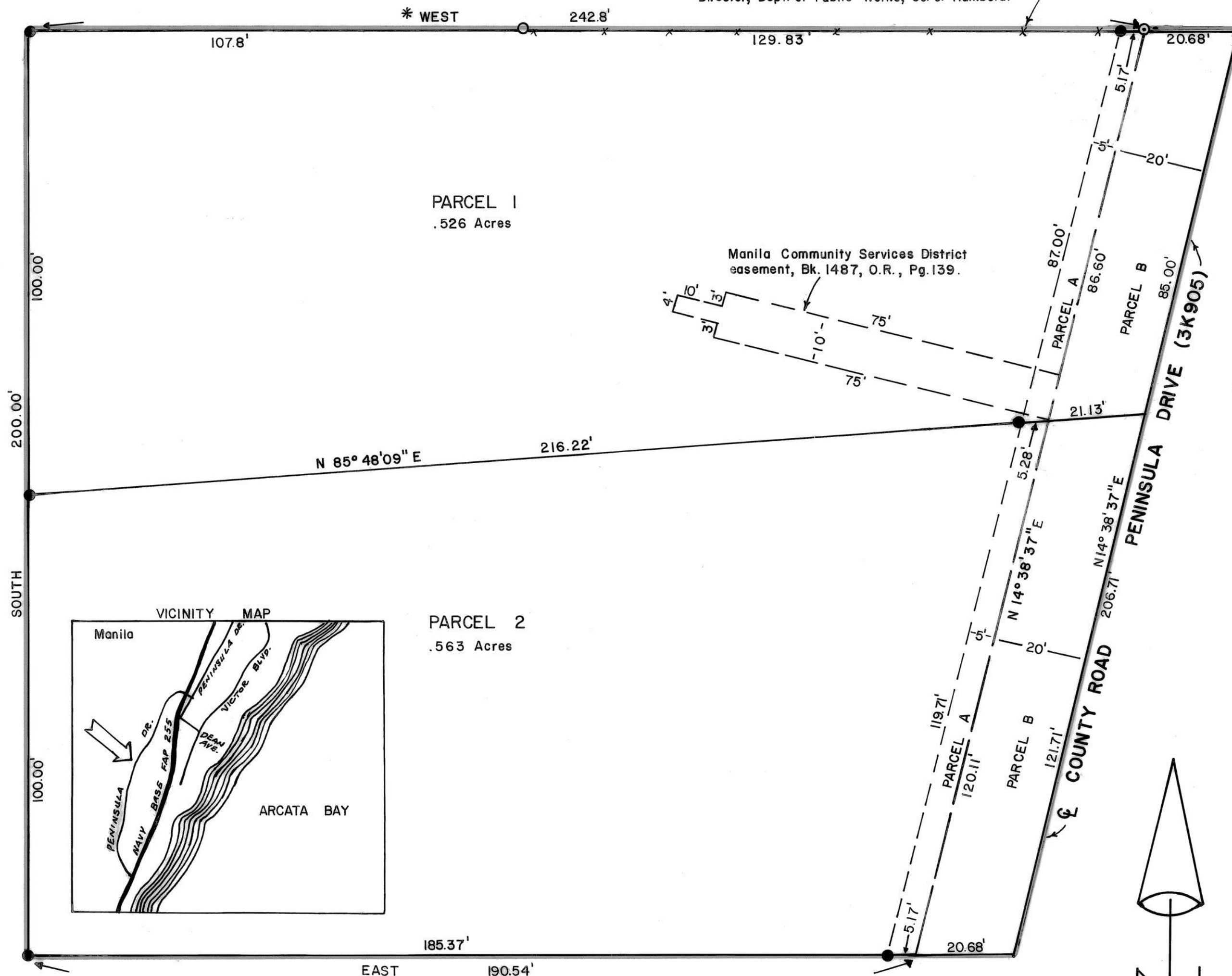
PARCEL B was previously dedicated in Book 155 of Deeds, Page 471.

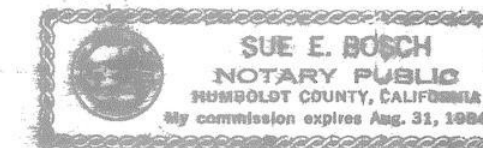

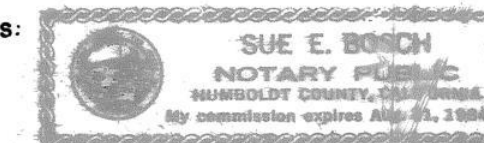
